### **IMPORTANT FACTS ABOUT YOUR NO FAULT DIVORCE**

1. All parties must sign.
2. The waiting period for a divorce is sixty days from filing. This does not mean on the 61 st day you are automatically divorced. All it means is that upon the expiration of this period then the attorney will make an appointment that is convenient to his schedule and that of the assigned judge to submit your divorce. Should the judge require changes, then all parties would have to sign the new documents.
3. Any time that there is a child involved in the divorce, then all persons must fill out a Financial Statement for the Judge.
4. The price paid for the divorce this date includes all information you have furnished above. Should there be any changes made to the terms requested above, there is an additional charge that must be paid when the new paperwork is prepared.
